APPLICATION FORM - ALLIED MEMBER (LARGE)

Allied Member (Large) is an ABM membership category for any entity with five or more permanent staff at time of signing.

New members pay a \$150 Entry Fee plus \$525 Annual Dues with their membership application. The first dues payment lasts for a whole year from when you joined. The second year, however, is prorated to July 1st (the start of our fiscal year) according to when you joined. For example, if you joined in January 2015, your first year \$525 dues cover you until January 2016—a whole year. Then, on July 1st of 2016 your second year dues invoice will be prorated for just six months that will cover you until July 1st of 2017.

This should not be of concern as it is policy by RBC Royal Bank of Canada and the Central Bank of the Bahamas. After going to the New York JP Morgan Chase, it gets routed immediately to RBC Royal Bank in the Bahamas, Main Branch and then into our Marina Operators Of The Bahamas account.
