Fees will be assessed and calculated according to the date when cancellation notice is received. Businesses that change ownership must inform the MOB in writing. The new owner shall be deemed liable for unpaid or outstanding dues up to the time change of ownership notice is received in writing.

TWO WAYS TO PAY ANNUAL MEMBERSHIP DUES

According to the Amended Articles and Board resolutions of April 2016, and starting September 2016, Operator Members have a choice of how to pay for Member Dues. Please make payable to Marina Operators of The Bahamas

OPTION 1 — PAY EACH MONTH A 2% LEVY ON DOCKAGE AND MOORINGS

Members can choose to collect and pay a monthly 2% levy on revenues on dockage, moorings or slips rentals (whatever the termed used). **The benefit to marinas is that member dues are no longer a cost to your business.** The 2% levy pass-through to the association is a voluntary donation from visiting yachts. Previous month's dues are payable on the 15th of the month. Members agree to provide accurate monthly accounts on dockage and moorings revenues if requested.

OPTION 2 — PAY DUES EACH YEAR, ONE-TIME

Alternatively, members can make an annual one-time payment according to the number of slips available as set out below. Dues are invoiced on July 1st and are paid by July 31 each year. New members pay \$150 and the entire year's dues at the time of joining. The second year of membership is pro-rated according to when the member joined the year previously. New members. Dues do not attract Value Added Tax (VAT)
